The Asset consisting of Property of the type "Terminal for unloading and storing petroleum products (bitumen)", located within the built-up area of the Commune of Holboca is sold in bulk, as a functional asset, as it is presented, for the value of **2.561.247,00 EUR, VAT excluded.** 

The prices do not include VAT. The provisions of art. 292, letter F, of the Fiscal Code, are to be applied to the extent of meeting the legal requirements.

If on the date set for the auction session, on 12.12.2019, the assets of the debtor PETROLBIT SRL will not be capitalized, new auction sessions will be organized under the same conditions, on 19.12.2019, at 11:00, at the headquarters of the Official Receiver EuroBusiness LRJ SPRL, in Iasi, 11, Zorilor Street, Iasi County.

The persons claiming a right over the assets to be offered for sale have the obligation, under the sanction of forfeiture of right, to prove this fact <u>by 11.12.2019</u>, <u>respectively 18.12.2019</u>, <u>12:00</u>, at the headquarters of the Official Receiver EuroBusiness LRJ SPRL in Iasi, 11, Zorilor Street, Iasi County.

In accordance with the provisions of art. 91, paragraph 1 of Law no. 85/2014, the assets alienated by the official receiver or the liquidator, during the performance of his/her duties, are acquired free of any encumbrances, such as mortgages, movable securities or retention rights, of any kind, or precautionary measures, except for criminal excussion.

The method of capitalization of the immovable asset is a public competitive outcry auction, according to the Sales Regulation approved at the Creditors' Assembly on 05.12.2019.

The bid increment is set at 5% of the auction upset price, according to the Sales Regulation approved at the Creditors' Assembly on 05.12.2019.

The guarantee for participating in the auction is of 10% of the auction upset price, VAT excluded, amount which will be deposited in the liquidation account of the debtor PETROLBIT SRL, no: RO66 BUCU 1032 2353 4114 6RON, opened with Alpha Bank, Iasi Branch. The guarantee for participation will be deposited in RON, at the NBR exchange rate on the date of payment. In case of winning the auction, the guarantee will be considered an advance payment and otherwise it will be returned to the bidder. Proof of record will be attached to the purchase offer, up to the deadline set for sale by public auction.

The asset can be visited and presented every Monday through Friday, with the consent of the official receivers, at the place where they are located. Official receivers will allow access to tenderers who will purchase the specifications, only in the presence of a representative thereof and upon the prior written request accompanied by an appointment to do so.
